### WCSA HDPE prices remain stable this week

HDPE film had a price decrease, but blowmolding and injection grade prices remained steady in the region despite mostly reduced US offers. The same source stated that, with packing capacity nearly full, logistics out of the US Gulf Coast may become problematic very soon.

PLASTICUPDATES evaluated high-density polyethylene filmgrade at \$960-990/mt CFR, down \$10/mt over the previous week. The assessment for HDPE injection was \$930-960/mt CFR, flat on the week. Flat per week, HDPE blow molding was assessed at \$930-960/mt CFR.

## **Brazil HDPE prices decline this week**

Weekly price changes in the CFR Brazil HDPE market were seen, although sources indicated that US bids continued to exert pressure. Local producers were under pressure as the prices of imported goods continued to decline. PLASTICUPDATES evaluated high-density polyethylene filmgrade at \$960-990/mt CFR, down \$10/mt over the previous week.

## **US HDPE prices decline this week**

The seasonal slowdown continued to weigh on the market, and for the week, high density polyethylene prices on a FAS Houston basis were viewed as constant to declining. PLASTICUPDATES evaluated blowmolding-grade high-density polyethylene at \$810-840/mt FAS Houston, down \$10/mt from the previous week. \$800-830/mt FAS Houston was the assessed price for injection-grade HDPE, which is \$10/mt less than the previous week. HDPE film grade was determined to be \$870-900/mt FAS Houston, which is the same as it was a week earlier.

### Turkey HDPE prices decline this week

In the week leading, the Turkish polyethylene market fell due to strong bids and little purchase interest. The CFR Turkey high density polyethylene film grade spot price was evaluated at \$920-950/mt, down \$40/mt from the previous week.

#### Asian HDPE market decline this week

The Asian HDPE market declined in the week due to fewer transactions and talks. Buyers were hesitant to buy because of the crude and market instability. Converter operating rates dropped as a result of the cost-of-living issue that affected exporters from Asia to the US and Europe's end markets due to skyrocketing loan rates and double-digit inflation. In the first quarter of the next year, participants were expecting lacklustre demand to persist and were aiming to maintain low stock levels to assist in improving their firms' cash flow. There were no obvious signals that economic conditions would change.

At \$920-950/mt CFR Far East Asia, PLASTICUPDATES evaluated dutiable unimodal film-grade high density polyethylene, up \$10/mt on the week. CFR Southeast Asia HDPE was at \$940-970/mt, up \$10/mt for the week. CFR South Asia HDPE film, which was up \$5 on the week at \$970-1,000/mt. Yarn-grade HDPE was evaluated as steady for the week at \$880-910/mt CFR Far East Asia. Yarn-grade PE steady at an uncontested intraday value of \$910-940/mt CFR Southeast Asia.

### **European HDPE prices increase this week**

In the week leading up to November 30, the European high density polyethylene market saw an increase in supply due to strong destocking sentiment and more aggressive import offers. The week saw little spot trading activity due to the continued weakness of the demand fundamentals. There was a lot of pressure on spot prices due to the rise in seller offers that were competitive, the plenty of supply, and the lacklustre demand.

The free delivered NWE unimodal film grade HDPE spot prices were stable and were assessed at Eur1,020-1,050/mt during the week. The FD NWE blow-molding grade HDPE spot prices were down by \$10/mt and

were assessed at Eur1,010-1,040/mt during the week. The FD NWE injection grade HDPE spot prices were down by \$10/mt and were assessed at Eur980-1,010/mt during the week
