Asia HDPE Prices see mixed sentiment this week

HDPE prices in the Asia region have experienced a mixed sentiment this week, according to the analysis by Global Market Plasticupdates analysts.

The mixed sentiment attributed to fluctuating upstream energy values, seasonal impacts like Ramadan, maintenance shutdowns, and anticipation of changes with the new fiscal year.

India:- HDPE Film prices were evaluated at USD 990-1020/mt CFR (down USD 10/mt).

HDPE BM prices were evaluated at USD 980-1010/mt CFR (down USD 10/mt).

HDPE Injection prices were evaluated at USD 970-1010/mt CFR (down USD 10/mt).

HDPE yarn prices were evaluated at USD 970-1000/mt CFR (down USD 10/mt).

Far East Asia:- HDPE film prices were evaluated at USD 950-980/mt CFR (steady).

HDPE blow moulding prices were evaluated at USD 910-940/mt CFR (steady).

HDPE injection prices were evaluated at USD 890-920/mt CFR (unchanged).

A Plasticupdates source reported that Keiyo Ethylene plans to shut down its Chiba, Japan cracker in April 2024 for scheduled maintenance. This facility has a propylene production capacity of 450,000 tons/year and an ethylene capacity of 768,000 tons/year.

PLASTICUPDATES:- PLANT NEWS (Pengerang Refining &Petrochemical)

A Plasticupdates source reported that Pengerang Refining and Petrochemical (PRefChem) has temporarily shut down its polyethylene (PE) units in Pengerang, Malaysia for maintenance. The units, with a combined production capacity of 400,000 metric tons per year for HDPE and 350,000 metric tons per year for LLDPE, are expected to be offline for approximately one month.

European HDPE Prices decline this week

HDPE prices in the Europe have experienced a decline, according to the analysis by Global Market Plasticupdates analysts.

The decline in HDPE prices in Europe is attributed to reduced trading activity ahead of the Easter holidays and the approach of April.

Anticipation of subdued demand in April, along with expectations of competitively priced import cargoes, has dampened market sentiment, leading to lower prices.

HDPE injection moulding grade prices reached Euro 1150-1180/mt FD North West Europe, marking a decrease of USD 40/mt from the previous week.

Turkey HDPE Prices remain stable this week
