Brazil LLDPE prices remain stable this week

The Brazilian CFR LLDPE market remained flat despite ongoing pressure from USGC offers. Due to the recent decline in US prices, dealers anticipated lower pricing for December and, in certain circumstances, postponed purchases in anticipation of lower prices in early 2024. Sources predicted that prices would drop further in November, particularly because there was less industrial activity following the second half of December due to vacations. Flat week over week, was the spot LLDPE butene pricing assessed at \$910-940/mt.

European LLDPE prices decline this week

Despite an uptick in competitive import offers, European LLDPE trade activity remained restricted in the week leading.

Over the week, the spot market saw an increase in import bids at levels that were lower than domestic pricing, which put a lot of pressure on spot prices. Throughout the week, there were noticeable discrepancies, but it was challenging to determine actual trade levels because of the lack of purchasing activity.

PLASTICUPDATES evaluated the spot price for European linear low density polyethylene C4 grade at Eur1,000 - 1,030/mt, free delivery to northwest Europe. This represents a decrease of Eur10/mt for the week.

US LLDPE prices decline this week

The week saw a decrease in linear low density polyethylene levels due to persistently low demand as the December holiday season draws near. Indicators for butene-grade LLDPE rail cars were heard in the 34-35 cents/lb range in the week leading. The FAS Houston spot export LLDPE butene prices were down by \$30/mt and were measured at \$840-870/mt.

Asian LLDPE prices increase this week

In the week leading up to November 30, the Asian linear low-density polyethylene market was uneven due to low demand and limited supply for some grades. Chinese circumstances, where the country's PE prices have been stable recently despite government assistance, will be crucial to any possible regional rebound. Market players in India said that while local inventory was being consumed, domestic prices were firming up. Offers for India will now depend on how local producers choose to occupy the market.

The CFR Far East Asian butene grade LLDPE prices were up by \$10/mt and were assessed at \$900-930/mt. The CFR Southeast Asia LLDPE prices up \$20/mt and were assessed at \$920-950/mt. The CFR South Asia LLDPE prices were up by \$10/mt and were assessed at \$930-960/mt during the week.
