# **US PET Export Prices remain stable this week**

PET export prices in the US remained unchanged, as reported by analysts from Global Market Plastic Updates. This stability may be attributed to a sufficient product availability and limited business deals.

PET export prices were assessed at the range of USD 1290 -1320 per metric ton.

## Asia PTA Prices decline this week

Purified Terephthalic Acid (PTA) prices in the Asia region have experienced a decline, according to the analysis by Global Market Plasticupdates analysts. This drop was attributed to persistent weak demand in the area.

CFR India PTA prices were assessed at USD 770-800/mt, down by USD 15/mt compared to the previous week.

CFR China PTA prices were assessed at USD 710-740/mt.

CFR South East Asia PTA prices were assessed at USD 720-750/mt, showing a decrease of USD 15/mt from the previous week.

# Asia PET see mixed sentiment this week

PET prices in the Asia region have experienced a mixed sentiment this week, according to the analysis by Global Market

India: PET prices were assessed at USD 940-970/mt CFR levels, remained unchanged from the previous week.

Plasticupdates analysts prices is attributed to a lack of purchasing interest, reflecting a sluggish trading environment.

South East Asia: PET bottle grade prices were assessed flat at USD 960-990/mt levels.

North East Asia: FOB North East Asia PET bottle grade prices saw a week-on-week drop to the range of USD 880-910/mt, down by USD 10/mt.
