Global Polymer Prices

PET prices in India were evaluated at \$920–950/mt CFR, consistently week over week. PET prices in Pakistan were evaluated at the same levels as last week, between \$1000 and \$1030/mt CFR. PET prices in Sri Lanka were evaluated to be consistent between \$950 and \$980/mt CFR.

European PET prices remain stable this week

Due to transportation concerns, buyers in the European polyethylene terephthalate spot market were growing more circumspect about availability. They sought to acquire additional material in the week leading up to February 3.

Longer journey times and greater shipping expenses from Asia to Europe are the results of Houthi attacks on commercial vessels in the Red Sea. Consequently, imported PET and virgin PET feedstocks such as pure terephthalic acid and paraxylene have either not reached Europe or have arrived at a higher cost.

PLASTICUPDATES evaluated the spot price of polyethylene terephthalate in Northwest Europe, which was stable during the previous week and assessed at Eur1130-1160/mt.

US PET prices increase this week

The week ending January 31 saw an increase in US polyethylene terephthalate import spot prices, mostly due to increased ocean freight costs. PLASTICUPDATES sources forecast thin market activity till after the Lunar New Year holidays. Demand for the virgin PET spot market was observed to be soft to stable during the week.

PET bottle-grade prices were valued at \$1,230–1,260/mt, up \$30/mt for the week. Domestic PET contract pricing was determined to be consistent each week at \$1,370/mt supplied by rail car.

Asian PET prices remain stable this week

PET prices were deemed unchanged in the Asian area this week, despite increased values for oil and MEG feedstock. There were reports of a constant purchasing pulse throughout the area. PET bottle grades from FOB North East Asia were evaluated at \$880–910/mt, with weekly fluctuations. The bottle-grade PET prices in Southeast Asia were found to be consistent each week, hovering around \$950–980/mt.

PET prices in India were evaluated at \$920–950/mt CFR, consistently week over week. PET prices in Pakistan were evaluated at the same levels as last week, between \$1000 and \$1030/mt CFR. PET prices in Sri Lanka were evaluated to be consistent each week between \$950 and \$980/mt CFR.
