US PP prices remain stable this week

This week saw no change in US PP export pricing despite increased upstream propylene rates. With plenty of material supply and weak demand fundamentals, the pricing undertone was constant.

PP homopolymer prices were evaluated at the \$1060–1090/mt FAS Houston levels, while PP copolymer prices were evaluated at the \$1110–1140/mt levels, both being constant from the previous week.

Prices for polypropylene increased this week in Southeast Asia while being unchanged in other Asian regions. The pulse of purchases in Southeast Asia was muted. In the meanwhile, Indonesian purchasers are still trying to find out exactly what has to be done to comply with the new PP import quota laws that will go into effect in March 2024. Even if spot discussions have been disrupted, the overall liquidity of the spot market has declined as buyers have refused to accept higher price offers due to the weak downstream demand.

Prices for PP injection grade and PP raffia in Southeast Asia were evaluated at \$950–980/mt CFR levels, both up \$(+10/mt) from the previous week. The costs of BOPP and PP film were evaluated at the CFR levels of \$960–990/mt, with a weekly increase of \$+10/mt. The price of PP block copolymer was evaluated at \$980–1010/mt CFR, up \$(+10/mt) from the previous week.
