Global Polymer Prices

- PLASTICUPDATES evaluated spot export copolymer PP prices at \$1,110-1,140 per metric tonne FAS Houston, reflecting the resilience of the homopolymer PP market.
 - CFR Turkey polypropylene fibre spot prices were valued by PLASTICUPDATES at \$1,190–1,220/mt on January 27, even with the previous day and \$10/mt higher than the week before.
- PLASTICUPDATES estimated spot pricing for homo injection-grade polypropylene at Eur1,000-1,130/mt, up Eur50/mt over the previous week. The current price for FD NWE copolymer PP was evaluated at EUR 1,160-1,190/mt, up EUR 50/mt over the previous week.
- PLASTICUPDATES' assessment of CFR Far East Asia's raffia/injection grade remained constant at \$840-870/mt. CFR FE Asia's raffia/injection grade remained constant at \$840-870/mt.
- The copolymer-grade PP was valued at \$1,130–1,160/mt, indicating a weekly decrease of \$10/mt.

US polypropylene prices remain stable this week

The week of January 30 saw difficult conditions for US spot export polypropylene, with prices remaining unchanged from the previous week despite a declaration of force majeure. During January 18–30, no further indications of spot exports were received. Given the present pricing of feedstock, PP is not feasible for export.

PLASTICUPDATES evaluated spot export homopolymer polypropylene prices at \$1,070-1,100/mt FAS Houston), which remained constant throughout the week. In light of no contradicting evidence, PLASTICUPDATES evaluated spot export copolymer PP prices at \$1,110-1,140 per metric tonne FAS Houston, reflecting the resilience of the homopolymer PP market.

Turkey polypropylene prices increase this week

The strikes in the Red Sea region continued to hamper imports, which kept the Turkish polypropylene market stable in the week

leading up to January 27. CFR Turkey polypropylene fibre spot prices were valued by PLASTICUPDATES at \$1,190-1,220/mt on

January 27, even with the previous day and \$10/mt higher than the week before.

European Polypropylene prices increase this week

In the week leading up to January 29, the European polypropylene market was still tight due to a decrease in import supplies and a shortage of the material domestically, which raised costs. Due to the Houthi rebels' attacks on commercial ships in the Red Sea, import availability from the Middle East and Asia continued to suffer delayed deliveries, leading market participants to refer to the situation as a supply crunch.

PLASTICUPDATES estimated spot pricing for homo injection-grade polypropylene at Eur1,000-1,130/mt, up Eur50/mt over the previous week. The current price for FD NWE copolymer PP was evaluated at EUR 1,160-1,190/mt, up EUR 50/mt over the previous week.

Brazil PP prices remain stable this week

Amid a calm market as the month drew to a close, the Brazilian market witnessed consistent import prices for PP homopolymer and copolymer throughout the week. Products of Asian origin have more affordable costs than those of Middle Eastern origin. A PLASTICUPDATES reporter reported negative oscillations in Asian items of about \$20/mt.

The spot homopolymer polypropylene price was evaluated at \$1,090–1,120/mt on January 30, flat week over week. The copolymer grade was determined to be \$1,170-1,200/mt, remaining consistent throughout the week.

Asian PP prices increase this week

In the week leading up to January 30, domestic prices of polypropylene in China saw a boost from restocking in preparation for the Lunar New Year vacations.

As of January 30, PLASTICUPDATES' assessment of CFR Far East Asia's raffia/injection grade remained constant at \$840–870/mt. CFR FE Asia's raffia/injection grade remained constant at \$840–870/mt.

CFR FE Asia IPP film grade pricing, which increased by \$5/mt to \$850–880/mt from the previous evaluation, CFR FE Asia BOPP grade pricing, which increased by \$5/mt to \$850-880/mt from the previous evaluation. CFR FE Asia block COPOL was valued at \$880-910/mt, \$5/mt more than the previous evaluation.

Copolymer grade PP was evaluated at \$950-980/mt CFR SE Asia; this was not altered from the previous evaluation. At \$990-1,020/mt CFR South Asia, PLASTICUPDATES graded the quality of raffia/injection, up \$15/mt from the previous evaluation.

WCSA PP prices remain stable this week

Attempts to raise prices in the WCSA market have not proved fruitful. A market participant in the PP market is finalising agreements in WCSA at \$1,130-\$1,160/mt. The problem of the Red Sea war has also prevented us from continuing to decline.

Spot homopolymer-grade polypropylene prices were unchanged during the week at \$1,130–1,160/mt as of January 30, according to PLASTICUPDATES. The copolymer-grade PP was valued at \$1,130–1,160/mt, indicating a weekly decrease of \$10/mt.
