European PVC Prices increased this week

PVC prices in the Europe have experienced increase, as reported by Global Market Plasticupdates analysts.

The price gain is attributed to seasonal demand fluctuations, changes in industrial activity, and shifts in consumer preferences can

all influence the supply-demand balance and consequently affect pricing.

FD North West Europe PVC prices were assessed at Euro 840-870/mt levels, marking a week-on-week increase of Euro

(+10/mt).

Asia PVC prices remain stable this week

The analysts from Global Market Plasticupadates reported that PVC prices in Asia region remained flat during the week.

This stability attributed to weak upstream crude prices, tepid downstream demand, and excess inventories.

India: PVC prices in India were assessed at USD 780-810/mt CFR levels, remaining stable from the previous week.

China: PVC prices in China were assessed at USD 750-780/mt CFR levels, unchanged from the previous week.

Southeast Asia: PVC prices in Southeast Asia were steady at USD 760-790/mt CFR levels.
