HDPE prices decline in Southeast Asia for Film and BM; Stability Holds in Injection and Yarn in Southeast Asia, India, and Far East Asia this Week

HDPE prices decrease in Southeast Asia for film and BM; Stability maintains in injection, yarn in Southeast Asia, India, and Far East Asia prices according to the analysis by Global market plasticupdates analysts.

The decline in HDPE film and blow moulding prices in Southeast Asia is due to weak demand, limited offers, and price uncertainties, while the stability in HDPE injection and yarn prices in Southeast Asia, India, and Far East Asia is driven by steady demand, balanced supply, and cautious procurement.

India:

HDPE film prices were evaluated at USD 910-940/mt CFR levels, showing no change week on week.

HDPE blow moulding prices were evaluated at USD 900-930/mt CFR levels, maintain stability week on week.

HDPE injection prices were evaluated at USD 910-940/mt CFR levels, remaining unchanged week on week.

HDPE yarn prices were evaluated remained flat at USD 900-930/mt CFR levels.

Far East Asia:

HDPE film prices were evaluated at USD 910- 940/mt CFR levels, showing no change from the previous week.

US HDPE film and BM prices increase, Maintain stability in HD Inj Prices this week

US HDPE (High-Density Polyethylene) film and BM; HD Inj remains stable, as reported by analysts from Global Market Plasticupdates.

The increase in HDPE film and blow moulding prices is attributed to tight spot availability, reduced export material in December, and rising ethylene feedstock costs. Meanwhile, price stability in HDPE injection is due to subdued market activity, with little change in transactional volumes and ongoing logistical challenges.

HDPE film export prices were evaluated at USD 840-870/mt FAS Houston levels, indicating a increase of USD \pm 10/mt compared to the previous week.

HDPE injection molding prices were evaluated at USD 800-830/mt FAS Houston levels, showing no change from the previous week.

HDPE BM (Blow Molding) export prices were evaluated at USD 840-870/mt FAS Houston levels, showing a increase of USD +40/mt compared to the previous week.

Latin America HDPE prices remain stable this week

HDPE (High-Density Polyethylene) export prices in the Latin America maintain stability, as reported by analysts from Global Market Plasticupdates.

Europe HDPE prices remain stable this week

The analysts from Global Market Plasticupdates reported that HDPE prices in the Europe remained flat during the week.

The stability in HDPE prices in Europe is attributed to weak demand, softening spot prices, and the impact of lower December ethylene prices.

HDPE film grade prices were evaluated at Euro 1050-1080/mt FD North West Europe levels, showing no change from the previous week.

HDPE BM grade prices were assessed at Euro 1040-1070/mt FD North West Europe levels, maintain stability from the previous week.

HDPE injection grade prices evaluated at Euro 1120-1150/mt FD North West Europe levels, showing unchanged compared to the previous week.

Turkey HDPE prices remain stable this week

The analysts from Global Market Plasticupdates reported that HDPE prices in the Turkey remained flat during the week.



Asia Ethylene prices remain stable this week

The analysts from Global Market Plasticupdates reported that Ethylene prices in the Asian region remained flat during the week.

The price stability attributed to subdued market momentum despite gains in naphtha values, with reduced market activity and the planned shutdown of JG Summit Olefins' cracker due to weak margins.

CFR India ethylene prices were evaluated at USD 890-920/mt levels, showing no change from the previous week.

CFR South east Asia ethylene prices evaluated at USD 890-920/mt levels, maintain stability from the previous week.

FOB Korea ethylene prices evaluated at USD 820-850/mt levels, showing no change from the previous week.

US Ethylene prices decrease this week

Ethylene prices in the US have experienced decrease, as reported by Global Market Plasticupdates analysts.

The decline in ethylene prices in the United states is attributed to deals concluded at lower levels, supply rebounds, and logistical logiams contributing to the downtrend in pricing.

Ethylene prices was evaluated at 26-26.50 cents/lb FD US Gulf levels, indicating increase of -1 cents/lb compared to the previous week.

European Ethylene prices see mixed sentiment this week

Ethylene prices in Europe have experienced a mixed sentiment this week, according to the analysis by Global Market Plasticupdates analysts.

The mixed sentiment ethylene prices in Europe is attributed to tight supply due to unscheduled production issues, an uptick in demand driven by early destocking, and weak overall demand with ample supply.

Spot ethylene prices in North West Europe were evaluated at Euro 760-790/mt FD (Free on Board) levels, indicating increase of USD +30/mt compared to the previous week's assessment.

CIF NWE ethylene prices were evaluated at Euro 710-740/mt, marking a decrease of Euro -10/mt compared to the previous week.

India Prioritizes Energy Security: Jaishankar Justifies Russian Oil Imports Amid Global Criticism

India's energy needs take precedence, asserted External Affairs Minister S Jaishankar, as he defended importing Russian oil amid global criticism. Russia now supplies over 35% of India's crude, a decision driven by national interest.

On the Russia-Ukraine conflict, Jaishankar emphasized the need for peace talks, reaffirming India's stance that negotiations are the only viable solution.
