Asia HDPE Prices remain stable this week

The analysts from Global Market Plasticupadates reported that HDPE prices in the Asian region remained flat during the week.

This Stability in HDPE prices is attributed to subdued market activity during Ramadan, steady buying patterns, and balanced supply levels across key Asian markets.

India:

HDPE Film prices were evaluated at USD 990-1020/mt CFR levels, unchanged from the previous week.

HDPE BM prices were evaluated at USD 980-1010/mt CFR levels, showing no change from the previous week.

HDPE Injection prices were evaluated at USD 970-1010/mt CFR levels, remaining unchanged from the previous week.

HDPE yarn prices were evaluated at USD 970-1000/mt CFR levels, no change compared to the previous week.

Far East Asia:

HDPE film prices were evaluated at USD 940-970/mt CFR levels, stable week on week.

HDPE blow moulding prices were evaluated at USD 910-940/mt CFR levels, stable week on week.

HDPE injection prices were evaluated at USD 880-910/mt CFR levels, stable week on week.

HDPE yarn prices were evaluated at USD 920-950/mt CFR levels, stable week on week.

Southeast Asia:

HDPE film prices were evaluated at USD 1000-1030/mt CFR levels, stable week on week.

HDPE BM prices were evaluated at USD 970-1000/mt CFR levels, stable week on week.

HDPE injection prices were evaluated at USD 980-1010/mt CFR levels, stable week on week.

HDPE yarn prices were evaluated at USD 990-1020/mt CFR levels, stable week on week.

PLASTICUPDATES :- PLANT NEWS (TotalEnergies' Gonfreville)

A Plasticupadates source reported that TotalEnergies' Gonfreville plant in France, which produces High-Density Polyethylene (HDPE) with a capacity of 300,000/Tons year, has extended its Force Majeure on HDPE supplies due to ongoing technical issues.

PLASTICUPDATES :- PLANT NEWS (Shenhua Baotou Coal Chemical)

A Plasticupadates source reported that Shenhua Baotou Coal Chemical in Baotou, China has temporarily closed its HDPE/LLDPE and PP Units for maintenance. The maintenance is scheduled to continue until the end of May 2024. The PP Unit has an annual production capacity of 300,000 tons, while the HDPE/LLDPE Unit has a capacity of 400,000 tons per year.

PLASTICUPDATES :- PLANT NEWS (ExxonMobil's Gravenchon)

A Plasticupadates source reported that ExxonMobil's Gravenchon plant in France, which commenced operations in April 2024, has a production capacity of 425,000 tonnes per annum for ethylene and 290,000 tonnes per annum for propylene. Despite efforts to enhance competitiveness, the plant faces closure due to accumulated losses exceeding €500 million since 2018.

PLASTICUPDATES: PLANT NEWS (Shell Pennsylvania Petrochemicals)

A Plasticupadates source reported that Shell has commenced operations for its second High Density Polyethylene (HDPE) Unit in Pennsylvania, USA, boasting a production capacity of 550,000 tons per year.

A Plasticupadates source reported that PetroChina Dushanzi Petrochemical's High Density Polyethylene (HDPE) Unit in Korla, China, is currently closed for maintenance on April 15, 2024. The annual production capacity of this unit is 300,000 tons.

European HDPE Prices decline this week

HDPE prices in the Europe have experienced a decline, according to the analysis by Global Market Plasticupdates analysts.

The decline in spot HDPE grade prices in Europe is attributed to a combination of factors, including a slowdown in trading activity, weak demand sentiments, and competitive pricing dynamics between imported and domestic products.

HDPE injection moulding grade prices reached Euro 1110-1140/mt FD North West Europe, marking a decrease of USD 30/mt from the previous week.

Turkey HDPE Prices remain stable this week

The stability in HDPE prices in Turkey is attributed to limited market activity, ongoing economic challenges, cautious converter behavior, and balanced import dynamics.

Asia Ethylene prices remain stable this week

Ethylene prices were evaluated at the range of 19.00-19.50 cents/lb FD (Free on Board) US Gulf, showing no change from the previous week.

European Ethylene Prices see mixed sentiment this week

Ethylene prices in Europe have experienced a mixed sentiment this week, according to the analysis by Global Market Plasticupdates analysts.

The mixed sentiment ethylene prices in Europe is attributed to factors such as hints of market improvement, ongoing macroeconomic challenges including inflation and high interest rates, and fluctuations in supply and demand dynamics.

Spot ethylene prices in North West Europe were assessed at Euro 780-810/mt FD (Free on Board) levels, showing a Increase of USD (+10/mt) from the previous week's assessment.

CIF NWE ethylene prices were evaluated at USD 820-850/mt, marking a no change compared to the previous week.

Indian Govt Increased windfall tax on crude oil

Indian government increased the windfall tax on petroleum crude from ₹6,800 to ₹9,600 per metric ton, effective April 16.

However, the tax rate for diesel and aviation turbine fuel remains at zero.

On April 4, the government had Increased the windfall tax on crude oil from Rs 4,900 to Rs 6,800 per tonne.

The initial imposition of the windfall tax in July 1, 2022 aimed to align domestic tax rates with international benchmarks, affecting crude oil producers and fuel exports.
