Asia's HDPE prices decline in India and Far East Asia, Maintain stability in South East Asia this week

HDPE Prices decline in India and Far East Asia, Hold steady in South East Asia prices according to the analysis by Global Market Plasticupdates analysts.

The prices decline in India and Far East Asia due to weak demand and lowered offers from overseas suppliers. In contrast, stability in Southeast Asia is attributed to steady trading and limited supply disruptions, with cautious market activity ahead of the year-end.

India:

HDPE film prices were evaluated at USD 900-930/mt CFR levels, marking decline of USD -10/mt compared to the previous week.

HDPE BM prices were evaluated at USD 890- 920/mt CFR levels, reflecting a decrease of USD -10/mt compared to the previous week.

HDPE injection prices were evaluated at USD 900-930/mt CFR levels, marking decline of USD -10/mt compared to the previous week.

HDPE yarn prices were evaluated at USD 890-920/mt CFR levels, reflecting a decrease of USD -10/mt compared to the previous week.

Far East Asia:

HDPE film prices were evaluated at USD 900- 930/mt CFR levels, marking decline of USD -10/mt compared to the previous week.

HDPE blow moulding prices were evaluated at USD 880-910/mt CFR levels, reflecting a decrease of USD -10/mt compared to the previous week.

US HDPE prices see mixed sentiment this week

HDPE prices in the US have experienced a mixed sentiment this week, according to the analysis by Global Market Plasticudates analysts.

The mixed sentiment in the market is attributed to weak demand affecting some prices, while others increased despite overall thinner market activity.

HDPE film export prices were assessed at USD 850-880/mt FAS Houston, indicating a increase of USD +10/mt compared to the previous week.

HDPE BM (Blow Moulding) export prices were assessed at USD 830-860/mt FAS Houston, marking a decline of USD -10/mt compared to the previous week.

HDPE injection export prices were assessed at USD 800-830/mt FAS Houston, showing no change compared to the previous week.

Latin America HDPE prices increase, Except HD Injection prices stable this week

Latin America HDPE prices experienced a increase, with the exception of HDPE injection prices maintain stability, according to analysis by Global Market Plasticupdates analysts.

The stability in HDPE injection prices is attributed to balanced supply and demand, while the increase in other HDPE segments is due to supply constraints and improved demand sentiments.

Europe HDPE prices continue to be stable this week

The analysts from Global Market Plasticupdates reported that HDPE prices in the Europe remained flat during the week.

The stability in Europe HDPE prices is attributed to sluggish market activity ahead of the holiday season, with buyers offloading stockpiles and demand-supply fundamentals remaining balanced.

HDPE film grade prices were evaluated at Euro 1040-1070/mt FD North West Europe levels, showing no change from the previous week.

HDPE BM grade prices were assessed at Euro 1030-1060/mt FD North West Europe levels, maintain stability from the previous week.

HDPE injection grade prices evaluated at Euro 1110-1140/mt FD North West Europe levels, showing unchanged compared to the previous week.

Turkey HDPE prices increase this week

HDPE prices in the Turkey have experienced a increase, according to the analysis by Global market Plasticupdates analysts.

The gain in Turkey HDPE prices is attributed to producers seeking price increases amid tight supply expectations for early 2025, despite weak demand and the impact of the depreciated Turkish lira.

CFR India ethylene prices were evaluated at USD 890-920/mt levels, showing no change week on week.

CFR South east Asia ethylene prices evaluated at USD 890-920/mt levels, maintain stability week on week.

FOB Korea ethylene prices evaluated at USD 820-850/mt levels, showing no change week on week.

US Ethylene prices increase this week

Ethylene prices in the US have experienced increase, as reported by Global market Plasticupdates analysts.

The gain ethylene prices in the United States is attributed to higher upstream crude values.

Ethylene prices was evaluated at 26.5-27 cents/lb FD US Gulf levels, indicating a Increase of +0.50 cents/lb compared to the previous week.

European Ethylene prices see mixed sentiment this week

Ethylene prices in Europe have experienced a mixed sentiment this week, according to the analysis by Global Market Plasticupdates analysts.

The mixed sentiment in Europe ethylene prices is attributed to surplus supplies in the market, despite lower run rates at European crackers, and weak demand fundamentals, which have left most market needs covered.

CIF NWE ethylene prices were evaluated at Euro 700-730/mt, marking a decrease of Euro -10/mt compared to the previous week.

Govt Considers Allocating OID Cess to Boost Exploration

The Ministry of Petroleum & Natural Gas (MoPNG) proposes allocating part of the OID cess to ONGC and OIL to support exploration and production efforts.

Despite paying over ₹16,000 crore in cess for FY24, these companies face financial strain due to high levies, impacting their ability to invest in new exploration projects crucial for India's energy security.
