HDPE Prices Decline in India, Maintain Stability in South East Asia and Far East Asia this week

HDPE Prices decline in India , Hold Steady in South East Asia and Far East Asia prices according to the analysis by Global Market Plasticupdates analysts.

HDPE prices declined in India due to weak downstream demand and pressure on buyers. In contrast, stability in Southeast Asia and Far East Asia is attributed to steady supply conditions and cautious market sentiment.

India:

HDPE Film prices were evaluated at USD 940-970/mt CFR levels, reflecting a decline of USD -10/mt compared to the previous week.

HDPE BM prices were evaluated at USD 930- 960/mt CFR levels, marking a decline of USD -10/mt compared to the previous week.

HDPE Injection prices were evaluated at USD 940-970/mt CFR levels, showing a decrease of USD -10/mt compared to the previous week.

HDPE Yarn prices were evaluated at USD 930-960/mt CFR levels, marking a decline of USD -10/mt compared to the previous week.

US HDPE Film and BM Prices decrease, Maintain stability in HD Inj Prices this week

HDPE (High-Density Polyethylene) Film and BM export prices decrease in the US; HD Inj Remains stable, as reported by analysts from Global Market Plastic Updates.

The decline in HDPE Film and Blow Moulding prices is attributed to The decline in HDPE Film and Blow Moulding prices is attributed to bearish demand trends, weaker upstream ethylene values, and excess HDPE supplies. Meanwhile, price stability in HDPE Injection is due to consistent demand levels that have maintained pricing despite the overall market downturn.

HDPE Film export prices were assessed at USD 940-970/mt FAS Houston levels Marking a significant decline of USD -30/mt compared to the previous week.

HDPE Injection molding prices were assessed at USD 880-910/mt FAS Houston levels, showing no change compared to the previous week.

HDPE BM (Blow Molding) export prices were assessed at USD 990-1020/mt FAS Houston levels, reflecting a decline of USD - 10/mt compared to the previous week.

Latin America HDPE Prices decline this week

HDPE prices in the Latin America have experienced a decline, according to the analysis by Global Market Plasticupdates analysts.

The decline in HDPE prices in Latin America is attributed to lower US offers and concerns over delays in US cargoes due to logistics issues at Brazilian and US ports, leading to reduced demand across all grades.

Europe HDPE prices remain stable this week

Asia Ethylene Prices decline this week

Ethylene prices in the Asia region have experienced a decline, according to the analysis by Global Market Plasticupdates analysts.

This decline is attributed to bearish regional purchase pulse.

CFR India ethylene prices were evaluated at USD 900-930/mt levels, reflecting a decline of USD -10/mt compared to the previous week.

US Ethylene Prices decrease this week

Ethylene prices in the US have experienced decrease, as reported by Global Market Plasticupdates analysts.

The decline in ethylene prices in the United States is attributed to unfavorable purchasing sentiment among buyers, which has led to reduced demand and subsequent price drops.

Ethylene Prices was evaluated at 24.50 -24 cents/lb FD US Gulf levels, reflecting a decline of -6.50 cents/lb compared to the previous week.

Europe Ethylene Prices decline this week

India's Oil Output Falls, Imports Rise in August

India's crude oil production declined by 3.4% to 2.4 million metric tons in August, while imports increased by 6.4%.

Oil and Natural Gas Corporation led domestic output at 1.6 million tons. Crude processing dropped 1.9% to 21.5 million tons, and import costs rose to \$11.4 billion due to higher LPG and lubricant imports.
