Asia PET Prices increase in NEA, Remain Steady in India and South East Asia this week

PET Prices increase in North East Asia, Remain Steady in India and South East Asia, according to the analysis by Global Market plasticupdates analysts.

The price gain in NEA is attributed to higher upstream feedstock rates and bullish MEG futures, along with buyers replenishing inventories ahead of the Chinese Golden Week holiday, while price stability in Southeast Asia and India is attributed to steady downstream demand and a lack of significant market changes.

PET Prices in India (CFR Levels) evaluated at USD 870-900/mt levels, showing no change from the previous week.

FOB North East Asia PET Bottle Grade Prices evaluated at USD 860-890/mt levels, indicating a increase of USD +30/mt compared to the previous week.

FOB South East Asia Bottle Grade PET Prices evaluated at USD 910-940/mt levels, Unchanged from the previous week.

PET export prices in the US have experienced a decrease, as reported by Global Market Plasticupdates analysts.

Asia PTA and MEG Prices increase this week

Despite frequent patrols by Chinese Coast Guard vessels in Malaysia's exclusive economic zone, the country continues expanding its drilling activities, particularly around the resource-rich Luconia Shoals.

China, which claims about 90% of the sea, faces resistance as Malaysia pushes forward with its hydrocarbon production.
