Asia PS prices decline this week

PS prices in Asia region have seen a decrease, according to the analysis by Global Market Plasticupdates analysts.

The decline in across Asia region PS prices is attributed to weak feedstock styrene prices, sluggish downstream demand, and competitive import offers, particularly from China, amid ongoing global trade uncertainties and inventory pressures.

India :

GPPS prices were evaluated at the USD 1130-1160/mt CFR levels, marking a substantial decline of USD -50/mt compared to the previous week.

HIPS prices were evaluated at the USD 1180-1210/mt CFR levels, reflecting a significant decrease of USD -50/mt compared to the previous week.

NEA:

GPPS prices were evaluated at the USD 1100-1130/mt CFR levels, marking a substantial decline of USD -50/mt compared to the previous week.

HIPS prices were evaluated at the USD 1200-1230/mt CFR levels, reflecting a significant decrease of USD -50/mt compared to the previous week.

Asia ABS prices decline this week

ABS prices in the across Asia region have experienced a decrease, as reported by Global Market Plasticupdates analysts.

The decline in across Asia ABS prices is attributed to falling feedstock costs, trade uncertainties, weak regional demand, and cautious buyer sentiment.

India : ABS prices were evaluated at the USD 1330-1360/mt CFR levels, marking a decline of USD -10/mt compared to the previous week.

China : ABS prices were evaluated at the USD 1320-1350/mt CFR levels, reflecting a decrease of USD -20/mt compared to the previous week.

US PS prices remain stable this week

The analysts from Global Market Plasticupdates reported that PS prices in the US remained flat during the week.

The stability in US PS prices is attributed to stable market conditions, with steady demand, sufficient supply, and unchanged producer pricing despite downward pressure from falling feedstock styrene costs.

GPPS export prices were evaluated at the USD 1440-1470/mt FAS Houston levels, while HIPS prices were evaluated at the USD 1510-1540/mt FAS Houston levels, both remaining constant from the previous week.

Europe PS prices decline this week

PS prices in the Europe have experienced a decrease, according to the analysis by Global Market Plasticupdates analysts. The decrease in Europe PS spot prices is attributed to lower styrene monomer costs, subdued demand, and reduced market activity.

GPPS (General Purpose Polystyrene) were evaluated within the range of Euro 1460 to 1490 per metric ton Free Delivered (FD) in Northwest Europe levels, marking a decline of Euro -20/mt compared to the previous week.

HIPS (High Impact Polystyrene) prices were evaluated between Euro 1560 and 1590 per mt FD in Northwest Europe levels, showing a decrease of Euro -20/mt compared to the previous week.

Europe ABS prices decline this week

ABS prices in the Europe have experienced a decrease, according to the analysis by Global Market Plasticupdates analysts.

The decline in Europe ABS spot prices is attributed to weak downstream demand, rising Asian imports, and falling feedstock costs, while contract prices remained stable amid supply concerns.

ABS prices in Northwest Europe were evaluated at Euro 1710-1740/mt levels, marking a decline of Euro -10/mt compared to the previous week.

Turkey PS prices decline this week

PS prices in the Turkey have experienced a decrease, according to the analysis by Global Market Plasticupdates analysts.

The decline in Turkey PS prices is attributed to lower European styrene monomer costs and competitive pressure from arbitrage-driven imports.

GPPS prices were evaluated at the USD 1350-1380/mt CFR levels, marking a substantial decline of USD -30/mt compared to the previous week.

HIPS prices were evaluated at the USD 1430-1460/mt CFR levels, reflecting a decrease of USD -20/mt compared to the previous week.

Asia Styrene Monomer prices decline this week

Styrene Monomer prices in the Asia region have experienced a decrease, as reported by Global Market Plasticupdates analysts.

The decline in Asia Styrene Monomer prices is attributed to combination of weaker upstream benzene values and unique bearish market sentiments.

India : SM prices were evaluated at the USD 870-900/mt CFR levels, marking a decline of USD -20/mt compared to the previous week.

China : SM prices were evaluated at the USD 820-850/mt CFR levels, reflecting a decrease of USD -20/mt compared to the previous week.

Southeast Asia : SM prices were evaluated at the USD 860-890/mt CFR levels, showing a decrease of USD -20/mt compared to the previous week.

US Styrene Monomer prices decline this week

Styrene Monomer prices in the US have experienced a decrease, according to the analysis by Global Market Plasticupdates analysts.

The decline in US SM prices is attributed to weak demand and sufficient supply, which have offset any upward pressure from rising feedstock benzene costs.

SM prices were evaluated at the 42.50- 43.00 cents/lb FOB US Gulf levels, marking a substantial decline of -3.00 cents/lb compared to the previous week.

India Pushes Back on Saudi Arabia's Multi-Billion Dollar Refinery Plan Amid Deepening Crude Oil Pricing Dispute

India Saudi Arabia's plan to invest in two refineries in India is held up by a pricing dispute. Saudi wants to supply half the crude at higher official selling prices, while India seeks a 20% stake with discounted prices.

This disagreement is causing delays, as Indian refiners feel there's little incentive without favorable terms. The stakes are high for both countries, with past investments also failing to materialize.
