Southeast Asia: PVC prices in Southeast Asia were evaluated at USD 760-790/mt CFR levels, showing no change week on week.

A Plasticupdates source reports Vynova shut its 275,000 tons/year Polyvinyl Chloride (PVC) plant in Mazingarbe, France, for maintenance work in early October.

## PLANT NEWS :- Braskem

A Plasticupdates source reported that Braskem has shut its No.1 and 2 Polyvinyl Chloride (PVC) plant in Maceio, Brazil, with 460,000 capacity.

## US PVC Export prices decline this week

PVC export prices in the US have experienced a notable decrease, as reported by Global Market Plasticupdates analysts.

The decline in PVC export prices in the US is attributed to persistently weak demand leading to lower market offers, while stability in Asian PVC prices is attributed to seasonal demand weakening, a lackluster market atmosphere, and expectations of destocking as buyers hold off on new commitments while waiting for November loading offers in light of the approaching holiday season.

FAS Houston PVC export prices were evaluated at USD 650-680/mt levels, reflecting a decline of USD -30/mt compared to the previous week.

## Latin America PVC Prices remain stable this week

The analysts from Global Market Plasticupdates reported that PVC prices in the Latin America remained flat during the week.

The stability in PVC prices in Latin America is attributed to limited offers and adjustments to recent PVC import tariff increases, with most buyers having already made their purchases.

CFR Brazil prices of PVC Suspension grade were evaluated at USD 820-850/mt levels, showing no change compared to the previous week.

CFR West Coast South America prices of PVC Suspension grade were evaluated at USD 740-770/mt levels, Constant week on week.

## European PVC Prices increase this week

## Asia EDC & VCM Prices stable this week

## US EDC & VCM Prices remain stable this week

## Europe EDC & VCM Prices remain stable this week

## India Navigates Sanctions: Legal Imports of Russian Crude via Sanctioned Tankers

Indian refiners are successfully importing Russian crude oil using tankers owned by sanctioned entities, with no violations of international sanctions.

A U.S. official confirmed that "General Licence 93" allows India to receive vessels from the Russian state-owned company Sovcomflot, ensuring a steady supply of oil despite geopolitical tensions.
